SCHEDULE OF EVENTS:

Registration Opens: September 1, 2017

Entry Deadline: Midnight, October 8, 2017

The entry fee, the entry form, and digital images of the artwork must be submitted no later than Midnight, October 8, 2017. Mark this date on your calendar. There will be no exceptions to deadlines, specs or rules.

Notifications emailed in the newsletter and separate email.

Show Opening: October 31, 2017

Show Closing Date: December 31, 2017

Juror and Awards Judge: Jacob Aguiar

Jacob Aguiar has been working in pastels for several years, and is passionate about the medium. Jacob has won several international pastel awards including awards in the 2015, 2016, and 2017 Pastel 100 competitions, 2017 First Place Overall UART Pastel Paper Online Show, Best of Show in the 2016 Pastel Society of New Hampshire annual show, and 3rd place in the 2016-17 Plein Air Salon Competition. An IAPS Master Circle member (IAPS-MC), signature member of the Pastel Society of America, and professional artist member of the Copley Society, he is currently teaching regular classes in Westbrook, ME, as well as workshops throughout the country and internationally. Eligibility:

- Only digital images of original paintings will be accepted.
- No work from copyrighted images will be accepted. Written permission to use a reference photograph by someone other than the artist must be obtained for the painting to comply with copyright laws and PSC requirements.
- If used in your paintings, collage materials must be created by the artist.
- All artwork must be at least 80% soft pastel
- Work completed under supervision in a class or workshop is not eligible.

- Paintings must have been completed within the last two years and not previously shown in any Pastel Society of Colorado show.
- Paintings entered into the online show are eligible for future PSC shows through the following calendar year.

ENTRY FEE:

- For PSC members up to 3 paintings may be submitted for \$25, 4 for \$35, or 5 paintings for \$45.
- For non-members up to 3 paintings may be submitted for \$35, 4 for \$45, or 5 paintings for \$55.
- The entry fee is non-refundable and must be paid at time of entry. Entry deadline is midnight on October 8, 2017. Payment for the show can be made using the PayPal button on the PSC website.

REPRODUCTION OF IMAGES: Entering artists agree that images submitted into Illuminated Online Show may be used by the PSC for promotional marketing.

DIRECTIONS FOR ENTERING Illuminated:

Step 1 – Go to Pastel Society of Colorado Shows and Events page www.pastelsocietyofcolorado.org/shows.php. Go to the Illuminated Online Show Listing.

Step 2 – Hit the Register and Pay button at the bottom of the Illuminated Listing.

Step 3 - Fill out the Registration Form. THIS ENTRY FORM IS CONSIDERED A CONTRACT and must be completely and accurately filled out with all requested information regarding the paintings and the artist.

Step 4 – Prepare and upload your images. The images must be formatted according to the following specifications:

- File Format: jpg (jpeg) only
- File Dimensions: The image should be 1920 pixels on the longest side
- Name the jpg (or jpeg) file: The file must be labeled with the first 4 letters of your last name, first 4 letters of your first name, and the entry number (ie. David Jones 1st entry - the image file would be JoneDavi1.jpeg, the 2nd entry would be JoneDavi2.jpeg).

Step 5 – Browse to find your images to attach them to the entry form

Step 6 – Enter your payment information (payment varies if you are a current member or a non-member). You must complete your entry by making your payment.

Step 7 – Submit the form (it will send your information to illuminated@pscshows.com)

** If your form is submitted and returned with errors, please fix the fields that are noted and check to be sure all images are still attached (or attach again if needed) before submitting again. You must make your payment in order for your submission to be completed/accepted. Payment via PayPal account or credit card.*

AWARDS: Awards are made at the discretion of the judge, Jacob Aguiar. All awards will be final with no exchanges or substitutions. The show will be displayed on the PSCshows.com website with winners prominently exhibited. PSC members who win an award in the show are entitled to 1 point toward PSC Signature status (not Master Signature Status). We anticipate more than \$600 awarded in prizes.

SALES: PSC will connect any potential buyer with the artist. There will be a 10% commission to PSC. PSC accepts NO liability in the transaction of the sale.

SHIPPING: To be paid by the buyer or arranged by the artist. PSC accepts NO liability in the shipping of the artwork.
